# Rules of use for Schattenspringer Adventure Parks, Schattenspringer GmbH, ("Adventure Parks").

## 1. Applicability of the rules of use

The rules of use apply to the following Schattenspringer Adventure Parks:  
SeaTree – Steinhuder Meer Adventure Park, Warteweg 4, 31535 Mardorf  
PirateRock – Hannover Tightrape Park, Landwehrdamm 11, 30916 Isernhagen  
TreeRock – Hochsolling Adventure Park, Schießhäuser Str. 8, 37603 Holzminden – Silberborn  
MiniRock – Children's Climbing Park at TreeRock, Schießhäuser Str. 8, 37603 Holzminden – Silberborn  
HanseRock – Hamburg Tightrape Park, Am Inseipark 22, 21109 Hamburg

It is the responsibility of each user of the Adventure Parks to read the following conditions and terms of use before entering and using the Adventure Parks, to confirm his agreement in writing, and to strictly comply with them. For usage by minors, the legal guardian or appointed agent must instruct the minor regarding the rules of use and enforce strict compliance, which must also be certified in writing. The name of the legal guardian or appointed agent and that of the participating minor are required. For users from 8 to 13 years old at SeaTree and PirateRock, from 6 to 13 years old at TreeRock and HanseRock, or 3 to 10 years old at MiniRock, the legal guardians or appointed agents are solely responsible for supervision while visiting the Adventure Park. Unconditional compliance with the rules of use by each user must be ensured; nevertheless, it is clear to each user that entering the Adventure Park is associated with risks. Therefore, use of the Adventure Parks is at the user's own risk, given proper fulfillment of the agreement by the operator.

## 2. Theoretical and practical safety instruction

Each user must receive practical and theoretical instruction before entering the Adventure Park. Instructions from the staff must be strictly followed. If, after receiving safety instruction, a participant does not believe he is able to correctly follow and comply with the required safety rules, he may not enter the Adventure Park. In this case the user is entitled to receive credit for the entry fee. Participants who violate the rules of use or staff instructions intentionally or through gross negligence may be barred from using the Adventure Park. Those persons are then not entitled to reimbursement of the entry fee.

## 3. Eligible users (minimum age, physical fitness)

Participants 6 years old or older may use HanseRock and TreeRock. Participants 8 years old and older may use SeaTree and PirateRock. Children from 3 to 10 years old may use the MiniRock Children's Climbing Park. Persons suffering from an illness, physical or mental impairment that can present a hazard for themselves or others when using the Adventure Park are precluded from using the Adventure Parks. Persons under the influence of alcohol, drugs, or medication are also precluded. Pregnant women may likewise not use the Adventure Parks, nor persons whose weight exceeds 120 kilograms.

## 4. Safety equipment

The safety equipment provided by the Adventure Park, consisting of full-body harness, helmet, and connectors, must be used according to the staff instructions and may not be removed or transferred to other persons while in the Adventure Park. The safety system may not be manipulated or damaged or otherwise circumvented. In the event of uncertainty or problems, the participant must summon the staff or have them summoned without delay. Smoking is prohibited while wearing safety equipment. At SeaTree, PirateRock, and MiniRock, the two carabiners of the safety system may not under any circumstances be simultaneously detached from the safety rope. The complete safety kit must be returned at the end of the reserved climbing time. Damage caused by the participant must be promptly reported to the staff. If the reserved climbing time is exceeded, a surcharge of €4 must be paid for each whole or partial hour.

## 5. Personal property, clothing, equipment

Objects such as jewelry, scarves, bandanas, cell phones, cameras, backpacks, or purses that may present a hazard for the participant or for others may not be carried when in the Adventure Park. If they are nevertheless carried, this is at the participant's own risk. Note that strangulation or amputation accidents are possible. Long hair must be tied with a band such that it cannot be caught in parts of the equipment or the facility. Piercings must be removed before using the Adventure Park. We recommend wearing robust clothing that does not constrict freedom of movement. Closed shoes must be worn.

## 6. Maximum number of participants on a climbing feature

Each climbing feature may be used by no more than one person at a time. No more than two people may be present on the pedestals (platforms) at the same time. Zip line departures may not be used until the arrival area is free of other people. Wherever possible, participants must reduce their speed accordingly during zip line departures, for instance by running upon making ground contact.

## 7. Liability

The operator is liable to users for damages with respect to injury to life, limb, or health based on a culpable violation of duties by its legal representative or the representative's agents. For other damages, the operator is liable to users only in case of intentional or grossly negligent violation of duties by the operator's agents or representatives. In case of property damage or financial damage based on a violation of duties due to merely simple negligence, the operator is liable only to the extent typical, foreseeable damages are concerned.

## 8. Closure of the Adventure Park

The operator reserves the right to partially or completely suspend operations for safety reasons (fire, storm, severe weather, hail, rain, etc.). In this case the participant is not reimbursed for the price of entry. If the participant breaks off his visit to the Adventure Park early at his own request, there is likewise no reimbursement of the entry price.

## 9. Recording

The operator reserves the right to take photographs and make film recordings throughout the facility for advertising and information purposes. If a participant does not consent to this, he must explicitly so notify the Adventure Park. In this case the participant will be made identifiable with a different-colored helmet.

## 10. Saving clause

Should one or more provisions be legally invalid, this shall not result in the invalidity of the remaining provisions.

## 11. Consent

The Adventure Park participant/visitor certifies that he has carefully read and understood the above usage rules and notes, and certifies that he will comply with them. He simultaneously certifies that no grounds for exclusion provided for in item 3 apply to him nor to any minor under his supervision, nor that the undersigned himself nor any minors under his supervision are carrying prohibited items as set forth in item 5.
